PLEASE READ AND SIGN BELOW

MANAGER AFFIDAVIT: I understand that as the manager/coach I am responsible for the actions and financial obligations of my team. I agree to abide by the ASA Official Guide & Rule Book and the adopted Rules and Regulations of Southern California ASA including but not limited to the following:

1. I shall not be guilty of unsportsmanlike conduct or any acts contrary to the objectives and purposes of ASA.
2. I understand that a player has seven days from the date the Player Agreement Form is received by the Age Coordinator to withdraw from the team without the consent of the manager.
3. I/my team personnel shall not recruit player(s) who have signed an ASA Player Agreement Form with another ASA team or that is currently playing on a team in ASA Recreational League Play until after August 15 or until after the player's team is no longer eligible for Championship Play.
4. I shall provide to players/parents a pre-season team budget and a final accounting at the end of the season.
5. I shall not compete with or against a disqualified/suspended team, player, or coach after being notified of the disqualification/suspension.
6. I shall provide proof of Team Insurance (Accident/Liability) at the time of registration.
7. I shall not use any ASA logos or trademarks without expressed permission.
8. I am aware that ASA provides a coach's education program.
9. I shall have control of coaches, players, parents and fans while participating in games and tournaments.
10. I shall receive written permission from another team manager before asking a player to be a pick-up player on my team for an invitational tournament. (See Yellow Book – Temporary Release Form).
11. I shall release all players if my team is not entering ASA Championship Play. An ASA Championship Tournament takes priority over other tournaments or games.
12. I shall inform players that they are automatically released when:
 - a. Decision is made not to enter Championship Play
 - b. Decision is made not to enter any remaining Championship Tournaments (example: Regional at-Large or State Championship)
 - c. My team is eliminated from further Championship Play
13. I shall respect a team that is still competing in Championship Play by not attempting to entice a player as a pick-up player, or for next season's team. This includes all levels of Championship Play including teams competing in ASA League All-Star Championships.
14. I shall notify another team's manager before asking a player to be a pick-up player on my team for Championship Play.
15. I shall advance to the next level in ASA Championship Play, unless such failure is due to circumstance beyond my control.
16. I shall not allow myself or team personnel to be abusive towards our players, opposing team, spectators, umpires or ASA Representatives.
17. I shall, upon registration, complete a background check. I will insure that my coaches in the dugout with the team will also be ASA registered and complete a background check.
